High Blood Pressure: 30-Minute Morning Workout Could Help To Control It

High blood pressure is a disease that afflicts people worldwide. Do you know that one in every three Indians is troubled by this situation? It may not be surprising that people are falling prey to this disease due to processed food and busy/sedentary lifestyle. High blood pressure can cause fatal diseases related to:

- Heart
 - Kidney
 - Eyes
 - Brain in people.
- Apart from medicines, anybody can lower their BP naturally by making lifestyle changes. Some methods of dealing with high blood pressure include:
- Reducing salt intake
 - High intake of potassium-rich foods
 - Continuing certain physical activities
 - Reducing alcohol intake
 - Quitting smoking

30 Minute Morning Workout:- According to new research published in the American Heart Association Journal, a 30-minute workout or physical activity in the morning can help you reduce BP. It has positive effects on obese men and women. The study also showed that women who take short and frequent breaks during work throughout the day may increase the benefits of the workout. **55 to 80 years of age:-** Men and women between the age of 55 to 80 years were included in this study. Michael Wheeler, Ph.D. Candidate and lead author of the study, employed at the Baker Heart and Diabetes Institute in Melbourne, Australia, and the lead author of the study, said, "Traditionally the health effects of workouts and sedentary lifestyle have been studied separately. We did this study because we wanted to know if there is a combination of these behaviors on blood pressure can have a free effect". **More attention to food and activities:-** The study included 67 participants and was carried out on different scenarios. The identical study was carried out in a controlled laboratory environment and participants were given standardized food. Their BP and adrenaline levels were repeatedly tested. **BP of people doing fewer workouts:-** Researchers found that women and men who exercised in the morning had lower average blood pressure, especially systolic, than those who did not do morning workouts. At the same time, those women who exercised in the morning and took breaks at constant intervals during work showed a significant reduction in mean systolic blood pressure. **Women got more benefits:-** Wheeler stated, "A decrease in average systolic blood pressure for men and women who take breaks during work as well as performed workouts can reduce the risk of death from heart diseases and stroke. However, this decrease is more in women". He also said that people who sit for long hours also benefited from taking breaks, especially those who had a higher risk of heart disease.

Wheeler said, they want to focus on the aspect of:

- Sitting people
- Doing workouts with breaks

The conclusion:- People should do at least 30 minutes of workouts along with a healthy diet to prevent hypertension.

Dr. Reddys Launches Generic Oral Anti Epileptic Drug In US

NEW DELHI:- Drug firm **Dr. Reddy's Laboratories** Mob:- 09368696718, 09410210556, 09359503863, 09329621787, 09368010386 on Tuesday said it has launched generic anti-epileptic Vigabatrin powder for oral solution in the US market. The product is a generic version of Lundbeck's Sabril powder for oral solution, Dr Reddy's said in a filing to the BSE. The company has launched Vigabatrin powder for oral solution, USP in 500 mg per packet after getting approval by the United States Food and Drug Administration (USFDA), it said. Ministry Has Directed States To Create Intelligence Cells

With an aim to check illegal practices of manufacturing spurious drugs, the Health Ministry has directed states to create intelligence cells to expose and bust such rackets. These intelligence cells will work in coordination with the officers of state drug departments and the Central Drug Control Standard Organisation (CDCSO) to unearth the illegal activities of spurious drugs and their manufacturing units. The intelligence cells will also look for any contravention of the Drug and Cosmetic Act. The health ministry has sought all state drug controllers to strictly monitor the implementation of the intelligence cells under the Act. These directions were given at the third Annual Regulators Conclave for Central and State Regulatory Authorities recently held in Goa. "Already some states like Maharashtra, Andhra Pradesh, Goa and Delhi have their respective intelligence cells and they are doing good. The intelligence cells will create more surveillance. This will also help in sampling to ensure quality issues of drugs and pharmaceuticals. Also, it will help the department by infrastructure and manpower," a senior drug controller told ANI on condition of anonymity. "The intelligence cells will conduct surprise raids and inspections. They will keep a strict vigil on habitual offenders. They will also make out a planned strategy with focused modus operandi. The intelligence cells will generate a database to capture historical background and incidences," the official said. Informing about one such racket of spurious drugs which was unearthed by the Delhi Drugs Control Department, the official said, "In Delhi, huge stocks of ointments of leading brands namely Betnovate-C, Betnovate-N and Panderm ++ were recently recovered from Bawana area. The estimated cost of recovered goods is stated to be approximately Rs 1.4 crore." When contacted, Atul Nasa, who is Head of Office/Controlling and Licensing Authority in Delhi said, "It was a challenging task taken by the officers of drug control department by exposing the racket of manufacturing of spurious and counterfeit medicines of multinational brands." "Our drug inspectors had also collected the samples of all three drugs from the spot for analysis to ascertain the quality of drugs and to verify their genuineness. GSK company has now verified that it is a spurious sample and not manufactured by the parent company," Nasa added.

While the Minister during the meet stressed that confidentiality of patient data is a very sensitive issue and asked officials whether this provision has been included in the draft notification, AIOCD General Secretary Rajiv Singhal pointed out how can the security of data be assured online. AIOCD President J S Shinde exuded optimism on its meet with the Minister on online pharmacy issues. A delegation led by J S Shinde had met the Minister.

Cipla Has Clarified That It Has "No Plans" To Venture Into E-pharmacy

New Delhi:- Mumbai-based drug maker Cipla Mob:- 09335391184, 09760122456, 09759395698 has clarified that it has "no plans" to venture into e-pharmacy, looking to pacify a powerful lobby of over 8.5 lakh chemist outlets that threatened to boycott the company's products. "We understand that there are some unconfirmed media reports in the market related to Cipla partnering with an e-pharmacy company. We wish to emphasise that these media reports are unsubstantiated and there is no truth in the matter," Cipla told the All India Organisation of Chemists and Druggists (AIOCD) in an emailed statement Friday. Earlier this week, the AIOCD said it was planning to sideline and stop promoting products manufactured by India's third largest pharmaceuticals company after learning about its reported tie-up with online pharmacy chain, Medlife. In its email, Cipla told AIOCD that it values the role of offline chemists. "We have always stood for provision of accessible and affordable healthcare, improve ease of doing business and formulate policies that aid the domestic pharmaceutical industry. In this journey of ours, our channel partners have played a pivotal role in our efforts to provide quality medicines to the patients." AIOCD general secretary Rajiv Singhal confirmed to ThePrint that the lobby has received the email. "As per the clarification sent by Cipla in the mail to us, the company is not entering in any partnership with online pharmacy," he said. ThePrint reached Cipla for comment on its email to the lobby but there was no response until the time of publishing this report.

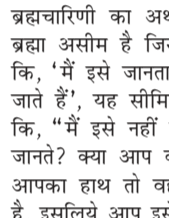

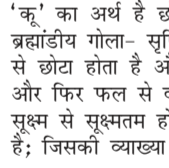
ब्रह्मचारिणी का अर्थ है अनंत में व्याप्त, अनंत में गतिमान - असीम ब्रह्मा असीम है जिसमें सबकुछ समाहित है. आप यह नहीं कह सकते कि, 'मैं इसे जानता हूँ', क्योंकि यह असीम है; जिस क्षण 'आप जान जाते हैं', यह सीमित बन जाता है और अब आप यह नहीं कह सकते कि, "मैं इसे नहीं जानता", क्योंकि यह वहाँ है - तो आप कैसे नहीं जानते? क्या आप कह सकते हैं कि, "मैं अपने हाथ को नहीं जानता. आपका हाथ तो वहाँ है न. इसलिये, आप इसे जानते हैं. ब्रह्म असीम है, इसलिये आप इसे नहीं जानते- आप इसे जानते हैं और फिर भी आप इसे नहीं जानते. दोनों ! इसीलिये, यदि कोई आपसे पूछता है तो आपको चुप रहना पड़ता है. जो लोग इसे जानते हैं वे बस चुप रहते हैं क्योंकि यदि मैं कहता हूँ कि, "मैं नहीं जानता", मैं पूर्णतः गलत हूँ और यदि मैं कहता हूँ कि, "मैं जानता हूँ", तो मैं उस जानने को शब्दों द्वारा, बुद्धि द्वारा सीमित कर रहा हूँ. इस प्रकार, ब्रह्मचारिणी वो है, जोकि असीम में विद्यमान है, असीम में गतिमान है. गतिहीन नहीं, बल्कि अनंत में गतिमान. ये बहुत ही रोचक है- एक गतिमान होना, दूसरा विद्यमान होना. ब्रह्मचर्य का अर्थ है तुच्छता में न रहना, आशिकता से नहीं पूर्णता से रहना. इस प्रकार, ब्रह्मचारिणी चेतना है, जोकि सर्व-व्यापक है.

माँ चन्द्रघटा



प्रायः, हम अपने मन से ही उलझते रहते हैं- सभी नकारात्मक विचार हमारे मन में आते हैं, ईर्ष्या आती है, घृणा आती है और आप उनसे छुटकारा पाने के लिये और अपने मन को साफ करने के लिये संघर्ष करते हैं. मैं कहता हूँ कि ऐसा नहीं होने वाला. आप अपने मन से छुटकारा नहीं पा सकते. आप कहीं भी भाग जायें, चाहे हिमालय पर ही क्यों न भाग जायें? आपका मन आपके साथ ही भागेगा. यह आपकी छाया के समान है. हाँ, प्राणायाम, सुदर्शन क्रिया बहुत सहायक हो सकते हैं; पर फिर भी मन सामने आ ही जाता है. मन को घंटे की ध्वनि के समान स्वीकार करें- घंटे की ध्वनि एक होती है, यह कहीं नहीं हो सकती, यह केवल एक ही ध्वनि उत्पन्न कर सकता है- सभी छायाओं के बीच मन में एक ही ध्वनि ! सारी अस्तव्यस्तता दैवीय शक्ति का उद्भव करती है- वो है चन्द्रघटा अर्थात् चन्द्र और घंटा.

माँ कूष्माण्डा



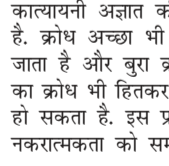

कात्यायनी



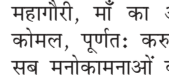
