New Definition Of Med Devices To Include Nebulisers, Syringes

NEW DELHI:- The health ministry is set to notify a new definition of medical devices which will expand the span of regulation to cover all such products, including diagnostic equipment, nebulisers, syringes as well as stents and other implants. The notification, already approved by the ministry, is expected to be notified by the end of this week, official sources told. "The new definition for medical devices will be aligned with that of the International Medical Device Regulators Forum (IMDRF) and one which is globally accepted," an official said. Once the new definition is notified, all medical devices will fall under the health ministry's regulatory purview and will have to undergo scrutiny by the Central Drugs Standard Control Organisation (CDSCO) before entering the market. This means companies will have to seek approval from CDSCO for manufacture, import and distribution of any medical device. Besides, they will also have to report adverse events and carry out clinical trials for new products as per regulatory requirement. All medical devices manufactured or sold in the country will also be monitored for quality, safety and efficacy. At present, only 35 medical devices are notified as drugs in India, of which 23 are regulated and the rest will come under regulatory purview from next year, according to the ministry's earlier notification. The regulator has also prepared a roadmap for regulating these products after consultations with various international regulators under IMDRF and inter-ministerial consultation. "The idea is to have a roadmap for medical devices so that manufacturing of products can be promoted in the country. Approval, certification and registration from a central authority under the health ministry will help in strengthening the credibility of 'Made in India' medical devices," the official said. The government is also working to bring a separate law to regulate medical devices. Besides, it is mulling an overarching pricing policy to cap trade margins of all medical devices. The medical devices industry, currently pegged at around \$7 billion in India, is growing at a CAGR of 4.5%. The sector is projected to touch \$9.6 billion by 2022. The implementation of regulation will start with licensing, which will be voluntary for 18 months and

become mandatory after 12 and 24 months, depending on their classifying category based on risks. Companies will be required to give details of products including design, shelf life and raw material along with other proof of evidence that their products are safe and efficacious. According to sources, all medical devices in the country – whether manufactured locally or imported – will be completely under the regulatory framework within three-four years. Medical device manufacturers, lobbying for a separate regulation for their products distinct from drugs, say all devices must be regulated to create a level-playing field and ensure patient safety.



New Device To Treat Type 2 Diabetes, Obesity: Study

London:- Researchers have found that a newly tested medical device, called "Sleeveballoon", mimics the effects of traditional bariatric surgery in rodents and produces impressive results on body weight, fatty liver and diabetes control. Sleeveballoon is a device that combines a balloon with a connected sleeve, which covers the initial parts of the small intestine. It is inserted into the stomach and bowel during minimally invasive surgery under general anaesthetic. For the study, published in the journal EBioMedicine, researchers compared the effects of the Sleeveballoon and traditional bariatric surgery on 30 rodents fed with a high-fat diet, achieving very similar results. Results were also compared to rats, with the new device reducing food intake by 60 per cent and resulting in a 57 per cent reduction in fat mass. The effect on diabetes was similarly impressive with blood glucose levels dropping by 65 per cent. "Gastric bypass surgery is a highly effective treatment of obesity and type 2 diabetes. However, very few eligible patients, only around one per cent, are offered surgery and some also prefer less invasive approaches," said study's lead author Geltrude Mingrone, Professor at King's College London. During the study, the research team found that the metabolic effects of the Sleeveballoon device are similar to those of the gastric bypass but have distinct advantages over the traditional method. In both, insulin sensitivity and heart functions improved. "However, while gastric bypass causes a rapid rise in post food blood glucose levels which can cause hypoglycaemia, the Sleeveballoon induces a slowing down of digestion which has a steadying effect on blood sugar levels," Mingrone said. "This helps control appetite and hunger, keeping the person fuller for longer and substantially reduces weight.



Scientists At City University Of Hong Kong Distinguished Cancer-Derived Nanovesicles By AuNIs-LSPR Biosensor

Cancer has always been a dreaded disease, which claims millions of life annually. The available cancer treatment options include chemotherapy, radiotherapy, and surgery depending on the location and stage of malignant behaviour of cancer. The early diagnosis of cancer has often been seen as a boon for the treatment of patients suffering from cancer, which requires biopsy; a method which requires collection of tissue sample from tumor followed by their analysis. The method of biopsy is highly invasive as it involves surgery, whereas the emerging of use of extracellular vesicles (EVs) such as exosomes and microvesicles (MVs), has led to development of non-invasive liquid biopsy.EVs are nanovesicle which are released from most of the cells, and biofluids including blood, cerebrospinal fluid, urine, etc. Their role has been found in metastasis of various cancer including glioma; a deadly brain cancer. Despite tremendous research on EVs, there has been a lack of clear consensus about the characterization of exosomes and MVs. Dr. Youngjin Lee (Department of Biomedical Sciences) and Prof. Chi-Man Lawrence Wu (Department of Material Science and Engineering) at City University of Hong Kong, discovered that the two important EVs derived from cancer cells react differently towards the gold nanoislands (AuNIs)-localised surface plasmon resonance (LSPR) biosensor. Their research team include Dr. Abhimanyu Thakur, Dr.GuangyueQiu, Dr. Siu-Pang NG, Jintao Guan, and Dr.Jianbo Yue. Their discovery suggests that exosomes and MVsposses different biophysical characteristics, which can be useful for liquid biopsy in cancer diagnosis as well as prognosis. Their work has been published in a top journal related to biosensing (Thakur A et al, Biosensors and Bioelectronics 2017, 94: 400-407; DOI: 10.1016/j.bios.2017.03.036). Dr. Abhimanyu Thakur said, "Cancer derived exosomes and microvesicleshave distinct biophysical characters, which can be used as a diagnostic marker. Our lab is still exploring this field by using advanced bioengineering tools such as atomic force microscopy (AFM), which are utilised for studying topological surface properties at manometer to picometer scale". Healthcare Sector On Road To Recovery: Icra

New Delhi:- The healthcare sector is on a recovery path after two previous years of muted performance marred by several regulatory measures, rating agency Icra on Monday said. The sector's performance had been adversely impacted in the past two years due to the cap on prices of stents and knee implants by the National Pharmaceutical Pricing Authority (NPPA), adverse impact of the GST rollout on profitability and strict regulatory action taken by multiple states, Icra said in a release. "The strong performance of the sector is in line with our expectations. This is further supported by the average revenue per operating bed (ARPOB) which grew at a healthy 9 per cent in Q1 FY'20 against 3 per cent in FY'18 and 6 per cent in FY'19," Icra Group Head and SVP Shubham Jain said. The growth in the ARPOB in Q1 FY'20 is much higher than the six-year compounded annual growth rate (CAGR) of around 6 per cent, on account of the hike in tariffs undertaken, he added. On the flip side, the regulatory environment continues to be the overarching challenge for the hospital sector with the wide-ranging regulatory restrictions from multiple authorities suppressing their margins, Icra said. "We continue to believe the performance of healthcare companies will improve further over the medium term, though any incremental regulation may have a transient impact," Jain said. Structurally, in the long term, underlying fundamentals like the significant shortage of beds in the country and the increase in the disease burden and an ageing demographic profile continue to favour the sector.
